Family of Women of Distinction Nomination Criteria

Family of Women of Distinction Award Objective:

To recognize a family of women (mother/daughter/grandmother/sister) living and/or working in Waukesha County, who by their association as a family and individually, have contributed to the community and reflect the qualities of Women of Distinction.

To further emphasize the leadership of award recipients, the Women and Girls Fund, in collaboration with honorees, will award a \$1,000 grant to a Waukesha County nonprofit organization in the name of the family of Women of Distinction honoree.

Award Criteria

The family must:

- Demonstrate sustained excellence, accomplishment and creativity in their professional and/or community endeavors.
- Demonstrate qualities of leadership, integrity, dedication, motivation, teamwork and resource management.
- Demonstrate qualities which encourage other women to view them as role models; help other women with their achievements.
- Demonstrate a commitment to improving the quality of life through work-related and/or community involvements.
- Be willing to be interviewed by media representatives and photographed for the luncheon program and media releases.
- Attend an evening reception on Monday, May 10, and accept their award at the luncheon on Tuesday, May 11, 2010.

How to Nominate

Submit the following information to the Waukesha County Community Foundation office by Friday, January 29, 2010.

- Completed and signed nomination form with verification that the family meets the nomination criteria and is willing and able to attend the Women of Distinction events outlined in the Award Criteria.
- A personal evaluation to indicate how the family meets criteria for the Family of Women of Distinction Award.
- A summary of the family's credentials and biographical information.
- Additional letter of recommendation (3 maximum); other supporting material (3 maximum).

Judging

1. Information provided will be the sole basis of evaluation by the judges.
2. If your nominee is not selected for this award, the family will receive a Special Recognition Honor.
3. Prior nominees may be re-nominated.
